### Pet First Aid & CPR Instruction with Denise Fleck

We love our dogs like we love our family and friends. We feed them the best foods we can find, provide regular exercise to keep them healthy and take caution when working them to avoid injury. But do we know the right thing to do in the event of an emergency? When facing a true medical emergency, every second counts and our faithful companions are counting on us to help keep them safe. We owe it to them to educate ourselves about the basics of Pet First Aid and CPR. Join us for a potentially life-saving evening of basic instruction in Pet CPR and First Aid with instructor and lecturer, Denise Fleck.

This presentation will cover Rescue Breathing, CPR, Shock, Chocking Management, Bandaging/Splinting and Hot Weather issues such as snake and insect bites, heat stroke and drowning. In addition to lecture and demonstration, 20 attendees will have an opportunity for hands-on practice with canine mannequins. Detailed handouts will be given. Please note, however, that this is \*not\* a complete Pet First Aid certification course.

No certifications will be issued at the end of this lecture.

Fleck will begin her lecture promptly at 7 pm. Please arrive on time. If you plan to bring your dogs for training before the lecture begins, please bring a crate or X-pen to confine them during the lecture.
