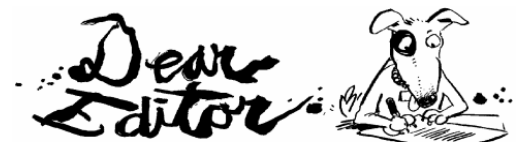
Curious about agility? Or are you a veteran agility competitor? Come one, come all! Join us for a fun-filled evening of agility practice and run-thru's!
