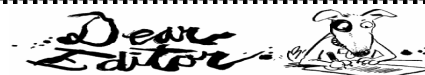

Laurie writes: "I really want to brag for Casey as this was his first title ever and it was amazing to see what he accomplished. This was also our first time herding goats, which handle so differently, but he did just fine. The large flock of 25 sheep was a sight to behold. On the course we had to open 11 different gates and move the flock through them, move them down an open road, hold them in a certain open area, call the dog off of the sheep then send him back to them, sort 5 out and put those 5 in and out of a horse trailer, put all 25 back together and move them around 3 panels in an arena then return them to the original pen—all within 30 minutes. Casey did it in 18 and was a real trooper throughout, never giving up. So now he is respectfully called **Ojai's Pacey Casey HTAD-1s**. Who says rescues are damaged goods...?"

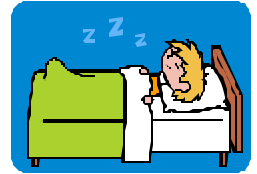

One male - His name is Jimmy, Caucasian (English/Irish mix), light blonde hair, blue eyes. Four years old. Excellent disposition. He doesn't bite. Temperament tested. Does have problems with peeing directly in the toilet. Has had chicken Pox and is current on all shots. Tonsils have already been removed. Tommy eats everything, is very clean, house trained & gets along well with others. Does not run with scissors and with a little training he will be able to read soon.



One female - Her name is Suzy, Caucasian (English/Irish mix), strawberry blonde hair, green eyes quite freckled. Two years old. Can be surly at times. Non-biter, thumb sucker. Has been temperament tested but needs a little attitude adjusting occasionally. She is current on all shots, tonsils out, and is very healthy & can be affectionate. Gets along well with other little girls & little boys but does not like to share her toys and therefore would do best in a one child household. She is a very quick learner and is currently working on her house training -- shouldn't take long at all.

We really do LOVE our children so much and want to do what's right for them; that is why we contacted a rescue group. But we simply can no longer keep them. Also, we are afraid that they may hurt our new puppy.

I hope you understand that ours is a **UNIQUE** situation and we have a real emergency here!!! They **MUST** be placed into your rescue by Sunday night at the latest or we will be forced to drop them off at the orphanage or along some dark, country road. 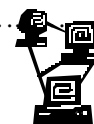
