AKC Updates

AKC's Title Application Portal (TAP)

AKC has developed a new online system to help make it easier for dog owners to apply for their dog's AKC title. It is called the [Title Application Portal](#) (TAP). The portal offers a fast and simple, step by step experience to apply for titles offered in Canine Good Citizen, Trick Dog, Temperament Test, Fit Dog, Fetch, Barn Hunt, Diving Dog, Disc Dog, Flyball, Virtual Home Manners, Search and Rescue and any one of the titles recognized under the [Parent Club Title Recognition Program](#). Users will need to login or create a MY AKC Account to begin. Dog owners can see each step of their transaction complete in real-time and confirm their order. Extended Pilot Program for Three-Legged (Tripod) Dogs in Non-Jumping Rally and Obedience Classes

At the August 2024 AKC Board of Directors meeting the pilot program was **extended through June 30, 2025**.

VHOC OBEDIENCE RALLY TRIAL RECAP

(Recap by Monica Nolan our VHOC Trial Chairperson)

We had a great Obedience/Rally trial at Burnley Park in Camarillo this past weekend -September 14th & 15th.

Entries were way up this year. On Saturday we had 167 entries (78 obedience, 89 rally). On Sunday, we had 176 entries (79 obedience, 97 rally). That's a 40% increase over last year!

The judges were Shannon Jones for Rally, Gail Katz for Novice Obedience classes, and Laura Delfino for Advanced Obedience classes. Shannon has been our rally judge for several years. Our trial is the only time she comes to the west coast to judge rally and everyone loves her. So we keep asking her back! To help save costs on her flight, we partner with Action Dog Sports who engages her for judging their agility trial on the Thursday and Friday before our event.

Laura Delfino is a well-known and well respected judge from Northern California. Although she has judged often in Southern California, this was her first time in LA/Ventura. She did an extraordinary job handling the large number of advanced obedience entries. On Saturday her ring had six runoffs and she didn't finish until 6pm.

Gail Katz is a provisional judge from the local area. She did a wonderful job with our novice classes, paying particular attention to the concerns of novice handlers. If it hadn't been for her offer to help, we wouldn't have been able to accept as many obedience entries as we did.

2. Preheat oven to 350 degrees
3. Using a wet dog food, a Pate is easier. You can also use raw, as long as you are able to spread it into the mold. Spread your treat choice into the mold. You can find spreaders and the silicone mold on Amazon.
4. Cook for 30 minutes.
5. Remove and let it cool before giving to your dogs as a treat. Be sure a keep them in a sealed container in your refrigerator when not in use, or freeze them for later.
