Are Ticks Active in Winter?

Ticks are alive and well winter, spring, summer, and fall – so your dogs need flea-and-tick medicine in the cold months, too. By **Dan Muse**, - **Published:** April 8, 2024, **Updated:** September 30, 2025

It's natural to wonder, are ticks active in winter? While ticks are typically less active once the temperatures begin to drop, there is still significant risk of tick bites—and contracting tickborne illnesses—in the fall and winter months.

Thinking that ticks pay attention to the start and end of winter is a potentially dangerous misconception. During a mild winter, ticks remain active. And even during a normal winter in a typically cold region, a few days above freezing can reanimate ticks. In many areas, winters are mild enough for some tick species to remain active throughout the season, putting your dog – and you – at risk on walks or hikes.

Even the most obsessive dog owners may let their flea-and-tick guard down when the winter winds kick in to save some time and money. The only problem is that skipping your dog's flea-and-tick preventative in the winter could come back to bite you and your furry family member.

Neither Ticks no Fleas Die in Winter

While most ticks may be dormant when the temperatures drop below freezing, fleas flourish indoors, so winter means little to these notorious bloodsuckers. They can attach to clothes, carpeting and more – and holiday travel may increase fleas' mobility – and eventually these annoying insects will bring your dog a miserable winter experience.

Dogs Need Flea and Tick Prevention in Winter

Using year-round flea-and-tick prevention for your dog offers uninterrupted protection, preventing infestations before they start. Stopping and restarting medication leaves your dog vulnerable. Early intervention – such as a regular medication regime and tick checks after a walk or run – is essential for preventing the spread of fleas and ticks.

While admittedly less of a risk for dogs, winter ticks feast on deer and moose, which can potentially threaten your dog if she spends significant time in areas frequented by these large animals. It's also rare, but your dog might inadvertently eat a winter tick while exploring an infested area and become ill.

Practicing year-long flea and tick protection is almost always a good practice, but if you're insistent that you don't need prevention in a region with consistently freezing temperatures and minimal indoor flea risk, discuss a seasonal approach with your veterinarian. Be aware, however, that some dogs with chronic illnesses may be best served by using year-round prevention.

When it comes to your dog, you can never be too conscientious. Most veterinarians recommend year-round protection but talk with him or her to determine the right approach, and possibly the right ingredients, for your dog. And, of course, take matters into your own hands and always check your dog for ticks, no matter how cold it is outside.

Can You Hurt a Dog's Feelings?

Animals used to be seen as not much more than machines—incapable of pain, preferences, or emotions. Thankfully, all that has changed, but questions remain about the inner life of animals, especially dogs.

Which leads us to ask: is it possible to hurt a dog's feelings?

Do Dogs Have Feelings?

Research shows that dogs and other animals possess rich emotional lives comparable to those experienced by humans. Here's what studies show about dog emotions:

- Dog brains are similar to ours and have the same structures that, in people, correlate to emotions like fear and happiness.
- Dogs produce hormones that are associated with certain feelings in people. Oxytocin, commonly referred to as the "love hormone," is a good example.
- Certain dog behaviors have been linked to identifiable emotional states. For example, research shows that dogs typically wag their tail to the right when they are happy.

Dog emotions are similar to those experienced by human toddlers. Dog cognition (mental ability) is similar to that of children who are 2–2.5 years old, and this likely applies to their emotions as well.

Can You Hurt a Dog's Feelings?

Because dogs do have emotions, it's natural to wonder whether we can hurt their feelings. Or, to put this question another way, can our words or actions make our dogs unhappy or sad?

In short, yes. What we do or say to our dogs has a noticeable effect on them. Praise them, and they're likely to wag their tail and break out into a goofy grin. On the other hand, telling your dog "no" when they drop a tennis ball at your feet will lead to disappointment, and maybe a little anger as well.

Some things that could hurt a dog's feelings are:

• Being ignored. Dogs are extremely social pack animals, which makes being ignored just about one of the worst things that can happen to them.

- Punishment when they're anxious or scared. Fear can lead to problematic behaviors like growling or urinating in the house. Dogs need a calm and safe environment to start feeling better. Yelling at—or worse, hitting—a scared dog just proves that they were right to have something to fear.
- Inconsistency. Dogs don't have a lot of control over their lives, but they like to know what's coming next. If your dog is used to spending some quality time with you before bedtime, for example, skipping this nightly ritual may make them sad.

Signs You're Hurting Your Dog's Feelings

A <u>dog's body language</u> can tell you a lot about what they're feeling. If you've hurt your dog's feelings, they might:

- Lower their head
- Have droopy ears
- Become less playful or enthusiastic
- Sigh, whine, or grumble

Dogs who act sad for an extended period of time may have <u>depression</u>. Many things can cause dogs to act depressed, like spending a lot of time on their own, a change in routine, the <u>death of a family member</u>, a <u>lack of exercise</u> and play, and medical problems like <u>hypothyroidism</u> and <u>pain</u>. Depression can lead to signs like:

- Drooping facial expressions and ears
- Acting withdrawn or excessively clingy
- Reduced interest in walks, playtime, and other favorite activities
- Sleeping more than normal
- Changes in appetite
- Reduced energy level
- Peeing or pooping inside the home
- Increased licking
- Increased shedding

Talk to your veterinarian if you have any questions about your dog's behavior or health.

How To Bond With Your Dog

It's natural for a dog to experience hurt feelings from time to time, but they should bounce back quickly, particularly if the two of you already have a strong bond. Here are some tips for developing or strengthening the bond between you and your dog:

- **Give your dog lots of attention.** Spend time together doing things that you both enjoy, such as going for walks, playing with their favorite toys, grooming them, and snuggling together.
- **Be consistent.** Let your actions show your dog that you are a reliable partner.
- **Be positive.** Training techniques that reward good behavior are best. Heap on the praise and avoid anything that feels like punishment. Continue working with your dog throughout their life to build a team mentality.

Can You Hurt a Dog's Feelings? - continued

Sometimes let your dog

be in charge. Dogs are often willing to go along with what we want, but sometimes it's nice to let them have a say. For example, go out on scent walks where your dog gets to pick the pace and route (as long as it's safe!), or don't force your dog to wear a Halloween costume if it's obvious that they're miserable in it.

If you put in the work to develop a strong bond with your dog, they'll forgive you if you occasionally hurt their feelings.


